Course Of Fire: All Slow Fire matches fired at 50 yards on B-6 targets Timed and Rapid Fire matches fired at 25 yards on B-8 Targets
Match #1 - .22 Slow Fire (20 shots)
Match #2 - .22 National Match Course (30 shots) 10 shots slow 10 shots timed (two five shot strings) 10 shots rapid (two five shot strings)
Match #3 - .22 Timed Fire (20 shots) five shot strings
Match #4 - .22 Rapid Fire (20 shots) five shot strings
Match #5 - .22 Aggregate
Matches #6-10, same as 1-5, except caliber is Centerfire
Matches #11-15, same as 1-5, except caliber is .45
Match #16 - Grand Aggregate

Challenge Fee \$2.00 (to accompany target for all matches)

Team Match is a paper non-fired match with scores from National Match Course

Registration: Teams must be declared and named at the time of first person registering and prior to the start of this match.

Facilities: Range has 25 covered firing points. **Squadding:** Preference given to three match 2700 gun shooters.

Eligibility: NRA membership encouraged but not required. ***TO BE ELIGIBLE*** for New York State awards, **you must belong** to either NYSRPA or your home state organization. Membership must be confirmed at time of registration. Membership applications for NYSRPA will be available at the range. Each competitor will be required to fill out and sign a Competitor information Fact sheet to be sent to the NYSRPA pistol director.

Class & Category: NRA system will be used. Fewer than 4 entries in a category, categories may be combined within the same class. If fewer than 4 entries in a class, competitors may be moved to their respective categories in the next higher class. Highest class will compete for open awards only. Unclassified competitors are assigned and compete in Master class.

Scoring: To be done by competitors on the line after each ten (10) shots. Plugs to be used by range personnel only. Competitors to provide their own stapler, staples and target repair tape or pasters. Scorecards must be surrendered when instructed by range personnel.

ENTRY FEES: CHECKS PAYABLE TO CASH

900 match is \$40. **1800** match is \$50. **2700** match is \$60. Four Person Team fee is \$16.00
EIC Pistol match is \$15. **EIC .22 Rimfire** match is \$15. **Distinguished Revolver** match is \$5.

Rules: All current NRA rules will govern competition.

Awards: Cash will be awarded by DCPA. New York State Awards by NYSR&PA for: Open Winner, & or, NY State Champion, 1ST High Master, 1ST Master 1ST Expert, 1ST Sharpshooter, 1ST Marksman, High Service/Police, High Senior (60 and over), High Grand Senior (70 and over) High Woman, High Junior, and High Team (2nd and 3rd place if enough entries). See ***ELIGIBILITY*** above.

EIC Service Pistol and .22 Caliber Rimfire Matches of Civilian Marksmanship Program

Eligibility: Open to all eligible participants. You need not be a member of the NRA or a CMP affiliated club to participate.

Time & Date: The afternoon of September 4th AFTER New York State Championship conventional 2700 match.

Fee: \$15.00 per competitor for each or \$30.00 for both.

Course of Fire: 30 round National Match Course of Fire. 10 shots slowfire

Firearm: "Service Pistol" and .22 Caliber Rimfire as defined in the Current Edition of the CMP Rule book

Equipment: Competitors must furnish their own equipment and ammunition in accordance with CMP rules.

Entries: There must be at least six non-distinguished shooters. Non-Distinguished shooters will get priority. May not be fired for practice.

Awards: EIC points towards Distinguished Pistol Shot badge. All awards and points will be issued by the CMP.

Rules: In accordance with the current edition of the CMP Rulebook. CMP Rules will govern all EIC Pistol Matches.

NRA Distinguished Revolver Match Fee: \$5.00

Eligibility: Only individuals who are eligible for NRA Pistol Competition pursuant to NRA Pistol rules shall be eligible to compete in this program. **MUST compete in State Championship to be eligible to compete in the Distinguished Revolver Match.**

Time & Date: The afternoon of September 4, 2016 AFTER New York State Conventional Pistol 2700 Championship match.

Awards: The NRA in accordance with their established guidelines will provide distinguished Revolver Badge and points.

Course of Fire: National Match Course will be used for all competitions under this program.

Ammunition: A Safe .38 caliber ammunition using the 158 grain round nose or semi-wadcutter bullet only provided by competitors.

Directions: DCPA range is 7 miles SE of Poughkeepsie, between US 9 & 376, near Dutchess County Airport. Use exit #13 on I-84, proceed 6 miles north on us 9, turn right onto New Hackensack road (DC #104), go 2 miles, turn right onto St. Nicholas Rd., range is 1 mile in on the left.
Breaks: After .22 match and Lunch after Center Fire. The kitchen may be open to provide low cost meals.
