**Match #3; #8** are Timed Fire for .22 caliber Center Fire & .45 calibers
Match #4; #9; #14 are Rapid Fire for .22 caliber Center Fire & .45 calibers
Match #5; #10 are Aggregates for .22 caliber Center Fire & .45 calibers
Match #16 is the Grand Aggregate for .22 caliber Center Fire & .45 calibers

COST: Three events **2700** fee is **\$45**. Two events **1800** fee **\$35**. One event **900** fee **\$25**.

FACILITIES: 25 covered shooting positions with electrically operated turning targets.

CLASS & CATEGORY: Competitor categories and classes may be combined if fewer than 5 entries.

AWARDS: Cash or NRA points. Highest class will compete for open awards only.

GENERAL RULES: NRA pistol rules will prevail. NRA membership is recommended but not required. Scoring to be done after each ten shot string by competitors on the line. Plug type scoring gauges are restricted for use by range officials. Challenge fee of \$2.00 must accompany targets. DCPA may exclude persons not conducting themselves in a proper manner. Smoking and alcoholic beverage consumption is forbidden while the matches are in progress.

DIRECTIONS: I-84 to exit #13. Route 9N for 6 miles to right on New Hackensack Rd. (DC 104) toward Dutchess County Airport. 2 miles to right onto St. Nicholas Rd. 1 mile to DCPA located on the left.

FOOD: Low cost cooked meals are available at most matches. Exception notices will be made.

NOTE: A brief break after the .22 matches and a lunch break after the CF matches.
